II. <u>PUBLIC COMMENT:</u>

- C. Elizabeth Davis: A proponent of keeping the same calendar. However, if the school has to change, she asked the board to consider the August 22nd start date.
- D. Randy Tenan-Snow: (not present but read by Karen Giffin) Randy is a proponent of the August 22nd start date with a two week winter break.

III. <u>ACTION ITEMS:</u>

2012 – 2013 PCHS PROPOSED CALENDAR CHANGE

The UTLA voting results were 82.4 % August 14 start date and 17.6% September 4 start date.

There was not enough teacher voice to put August 22^{nd} on the ballot; however, UTLA would consider a different calendar if the charter complex moves to a different calendar before the 2012-13 school year begins. The UTLA results were 82.4% in favor of an August 14^{th} start date and 17.6% in favor of a September 4th start date.

Julia O'Grady, parent liaison, sent out an email on December 12, 2011 to the parents in both English and Spanish. This email contained a survey for parents on calendar start date preferences. The results were (820 parents opened the email) 142 parents voted for Aug 14. 162 parents voted for the August 22nd start date. 116 parents voted for September 4th start date.

Motion: Made by Judi Firth: I move to have the PCHS 2012-13 calendar start on August 14 and end on June 4, 2013 with the following caveats: The school calendar will be revisited if the Charter Complex moves to a new start date, and the change has no negative budgetary impact to PCHS.
